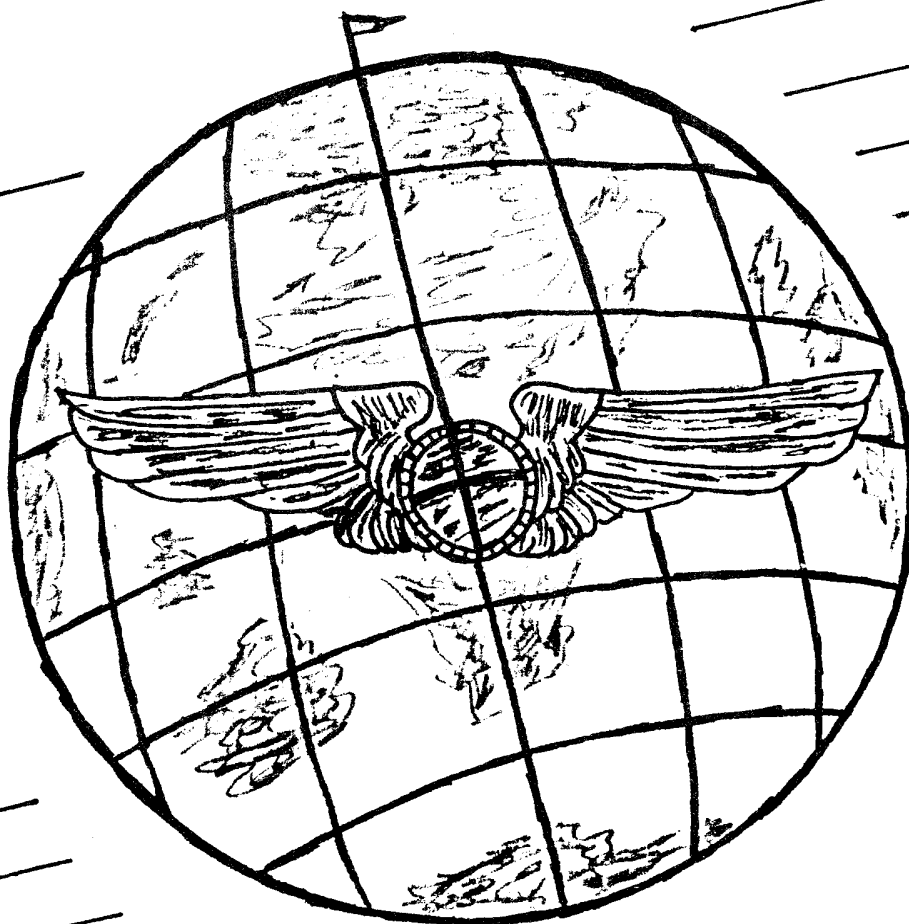

THE PAST:

An eternity ago, 1984 to be precise, I began to wonder what had become of my classmates of 50-D. Knowing the whereabouts of only three of them, a campaign was launched to locate the remaining 58. The plan at that time was to try to get them together in small regional groups, then perhaps have one big reunion. Through various channels, nine were confirmed dead, 43 were contacted, and 4 are still missing. Forty-four of them sent me BIOs, and two widows of classmates are still keeping up correspondence. Bud Langley, 50-D just happened to have a copy of the original DR AHEAD classbook layout from 1953 which he had preserved for 33 years. He was a great help. Fred Meier and Frank Cocoran helped bug classmates, and both Frank and Bud, whose wives are so gracious, held mini-reunions in their homes. Meady with success, I took the big plunge and started plans for a big reunion in Las Vegas in April of '86. Jack Mudie, 50-F, saw my ads and joined the quest, locating most of his class in short order. Clem Smith, 51-08, joined in and in addition to locating a large number of his classmates, gave me invaluable assistance in keeping the records of the now snowballing correspondence coming in from 'Gators of many of the classes of '50 and '51. USAA forwarded cards for me to those of you who are still on their records. More responded, and by the time I first heard from Ken Johnson, 51-03, the list had grown to nearly 200 names. To relieve the strain on Clem, Ken punched all the info into his computer, and can now pull us out by Class, State, Zip or blood type. There are currently 329 of you in the file, plus 79 known deceased. 41 states are represented as well as Guam, Korea, Italy and Australia.

The 'Vegas bash was planned, executed, and a big success! One hundred and sixty "Exes" and wives attended. A letter from Frank Cocoran describes the scene far better than I can, so it is published herewith in its entirety. Thank you Frank.

THE LAS VEGAS DR AHEAD REUNION

Upon arriving at the airport Thursday night, we questioned whether the whole thing was worth the effort. Would we enjoy seeing this bunch of strangers we knew 35 years ago? Could we feel comfortable with men we knew so well, so long ago? When we got to the hotel and ran into Clarke & Ruth Lampard and Fred & Libby Meier, doubts began to fade. We had dinner and a show with Barry & Roberta Bonwit. Bill & June Fuller and Lon & Mary Fongrace joined in the festivities. We felt it was old home week, just anxious to see more old friends.

On Friday many more people came to sign in. Each navigator was given a name tag consisting of his year book picture and his name. It was obvious Clarke Lampard had worked long and hard with match books, napkins, programs and a schedule for the entire weekend with the DR AHEAD logo. Familiar and unfamiliar faces crowded into a room with a warm, friendly atmosphere. A VCR cassette was shown almost continuously showing our old barracks, marching cadets, guys walking off their tours, planes on the line, off duty picnics, a tour of San Jacinto Monument, the reception after our wedding (June 10, 1950) and a tour of the zoo. Everyone kept identifying the faces appearing on the screen. Two busloads of us drove to Hoover Dam and toured the largest concrete structure in the U.S. The duffers played golf until dark and cold set in. Friends renewed old friendships and caught up with each others lives. Quizzical looks lasted only long enough to exchange names and expressions of recognition spread across faces.

The Friday evening cocktail hour started with the regular buzz of voices and brief shouts of recognition for the newly arriving guests. By the time Clarke wanted to start the program the buzz had become a roar of talk and laughter. Announcements were made, door prizes were given away and George Taylor, wearing his usual broad smile, presented each of his classmates of 50-D a very classy blue cap with Master Navigator wings with the wording "Navigator USAF, Cadet Class 50-D" and the silver scrambled eggs on the bill. There were no more doubts about the value of coming to the Gathering of 'Gators. It was an exciting and happy time to reminisce with the guys who had lived together 24 hours a day for 12 long months.

Saturday was more of the same comraderie and welcoming a few late arrivals. A busload of the dedicated aircraft fanatics visited Nellis AFB to view the lineup of aircraft brought in for the Gathering of the Eagles set a week following our reunion. They saw everything the base had to offer and had greater cooperation than they had hoped for. In the meantime, Bill Polhemus held a briefing, including slides, to show and discuss the state of the art in navigational aids and what DOD and DOT are planning for the next several generations. Bill also gave a marvelous talk on his adventures as navigator on a flight duplicating the last and fatal flight of Amelia Earhart, arriving at her planned destination within 10 minutes of her planned ETA. Her destination was a small island eight feet above sea level and not visible five miles away. The original navigator used the driftmeter and sextant basically and was depending upon a sunline landfall after a 19 hour flight. Bill's personal opinion is that the original flight failed due to exhaustion leading to a decision to start a search pattern after turning on the landfall.

The Saturday night dinner was spectacular with everyone resealed old friendships sidetracked by time and distance. Clarke thanked his helpers, the hotel staff, the kitchen crew and everyone who wears glasses and spits through his teeth. He was the one who deserved the accolades. The real point was not the menu nor how slippery the dance floor was. We basked in the aura of friendships lost and rekindled.

Sunday morning breakfast was a complete success with a vast array of good food and drink. Warm goodbys with earnest promises ended the happy and satisfying weekend. We can all hope that each class of Navigators will wish to continue in building an expanded organization with future reunions. Clarke has served his term in the dome and no one else has come forward to fill the void. Therefore, is there any choice but to toss the ball to each class and depend on the desire of that class to fill their membership?

My personal recommendation for EO-D is to vote, appoint or railroad the four guys who live in or near Houston as follows: Bill Fuller, Mike Gurdevich, Bob Schlegel and Tom Hanley as Chairmen. Let them have full rein to send out a newsletter, seek further addresses for Tanner and Vurgel and plan for a reunion at their own discretion. Bud Langley, Bernard Vash and I have not accomplished enough to give credence to mini-reunions even though we support such a gathering.

THE PRESENT:

The group who gathered at 'Vegas, perhaps still "High" on a first reunion summit, said "Clarke, find everyone who ever trained as a navigator at Ellington!" Then they slapped me on the back and went home. I too went home, but instead of being able to relax and say "You did good" to myself, I almost let this new "Assignment" (and I took it as one) get me down. During this period, continued correspondence with Ken Johnson and a few others convinced me to carry on. I asked those who attended 'Vegas to submit "Letters to the editor" to any publication/newspaper they read in their own areas. Some of them did because I am now getting letters and cards from men who graduated in 1943, '44, '52, '53, '55 and just this week one in '57. To each I send a brief recap of how it all began and a poop sheet which shows how I did it and what not to try. I also ask them to make copies and send them to anyone who ever trained at EAFB. To your class reps (years '50 & '51) I sent questionnaires and asked for feedback for this newsletter. The response was less than dazzling. What happened, Guys?

By vote of those attending the business meeting at 'Vegas, our name was changed to "TENA." I will continue to use DR AHEAD as the name for our newsletter. This group also more or less agreed upon 1986 for the next full reunion, and the consensus was for Houston as the site.

THE FUTURE:

I feel strongly that future reunions might be easier organized by regional committees, and that if we wait two years for the next one we will lose too many of us. When the summer was hottest and I was wishing I had never even started DR AHEAD, I got Ned Humphrey's newsletter "Crosshairs." It is a slick, professional organ with dozens of pages, but that's not what jacked me up. Two years ago, after a time period similar to the one I went through finding you, he had located just about 400 WWII Bombardiers who trained at many bases and had two reunions, each having larger attendance. Then he asked his roster to help him by submitting "Letters to the Editors." Today he has a roster of almost 4000. Next March their reunion will be in San Antonio for almost a week. There will be individual class "minis" and a multitude of parties and other activities. He expects in excess of 500 to attend, and is already planning for 1988 in Ohio. Ned has given me many tips on how to handle such a large organization. Hope I get to use them!

For those of you willing to help, try this: To each publication that you read, submit this plea: "Anyone who ever trained in Navigation at Ellington AFB is urged to write to Clarke Lampard / DR AHEAD, 5830 Robin Hill Dr. #2, Lakeport, CA 95453 for info on newsletter and reunions." It will only take a little of your time, and the results could be astounding. Just do that one little thing and I'll take care of the rest.

Ken Johnson threatens to send me his entertainment bill for for all the visitors this summer. Ruth and I visited Libbie and Fred Meier in Spokane in September for the wedding of their son. On Oct. 18 Joan and David Matson hosted a mini reunion at

their home in Palos Verdes Estates. P and I enjoyed seeing them, along with Bud Wiley and Stan Kozusyn, but wish more could have come. David entertained with film taken during his Korean B-29 missions. I felt as if I were there, but was actually much safer (and probably colder) "vacationing" in Greenland, Labrador and Alaska. (50 to 55). Bill Kesey, 43-18 was recently discovered in my church right here in Lakeport.

The 'Vegas Memory Book finally got published and delivered. Sorry about the misspelling of "Gaitors" on the cover. We certainly did not have a "Gathering of Spats." My apologies also to Bristow and Besanko for the misspelling of their names. I have several copies available for \$12 each if any of you want one. First come, first served while they last.

DOLLARS AND CENTS:

As most of you know, I have asked for an annual donation of \$10 from each of you to cover the costs of maintaining TENA. You may not realize what these costs are. 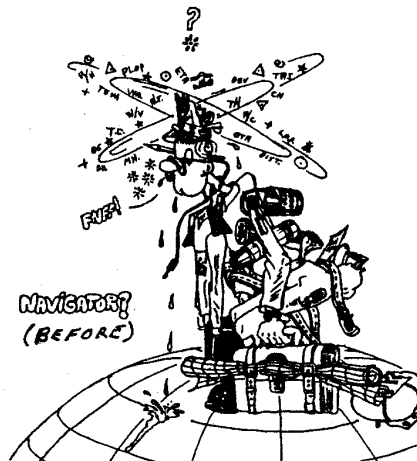
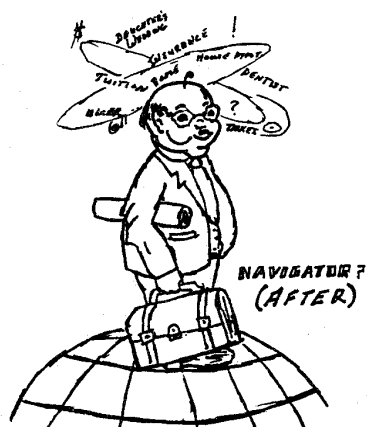
ERRATA:

Ellington AFB Navigation Classes started in Dec. '43 and continued until the last class graduated 24 March '45. 38,000 Aviation Cadets received training of some form there during this time. In 1949 three classes of ex-bombardiers and three Aviation Cadet classes started navigation training and each graduated in 1950. From '51 to '57 many officers were dual or triple rated as navigators at EAFB. I'd appreciate any information about any of these periods. When did the last class graduate? 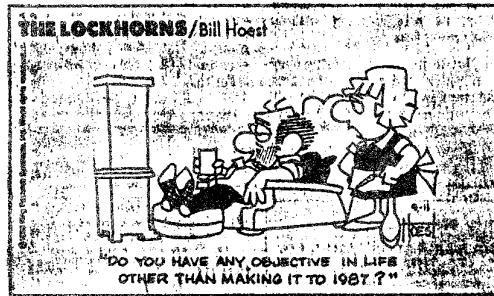

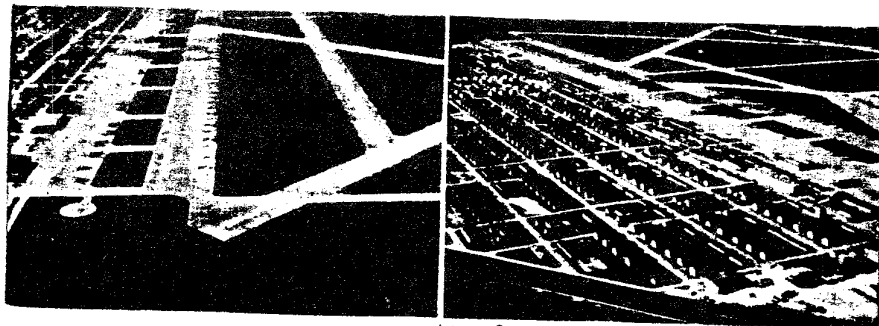
ADDEMDUM:

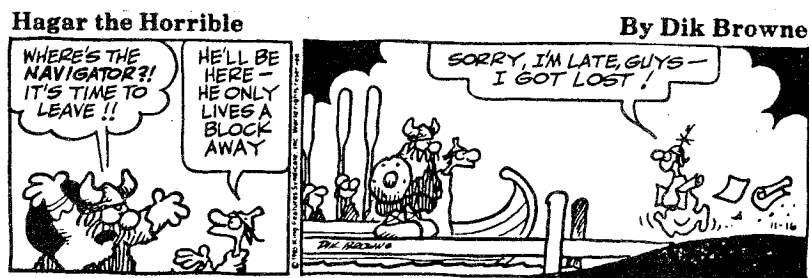
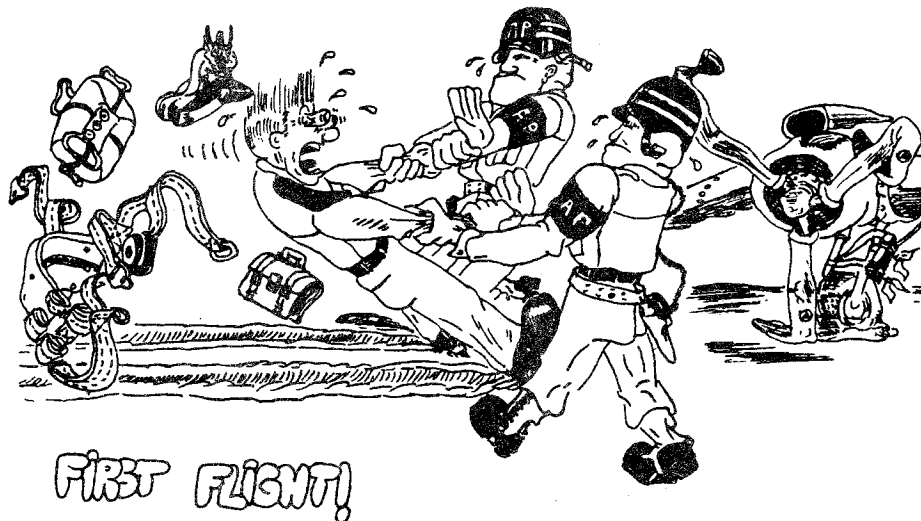
